7. ENTITLED TO DATA RECOGNITION

By signing a contract with Labtech Ltd (written order), you expressly consent to the personal data provided by you being the employees, senior officers, consultants, data processors or other employees of Labtech Ltd. and the partners to whom you have contributed, become acquainted and treated.

Based on regulatory requirements, the courts and authorities have the power to get to know some of the personal information treated.

8. DATA TRANSFER AND TRANSMISSION

By signing the Contract (written order), you expressly consent to the transfer of such data and warrant that personal data will be transferred to Labtech Ltd. for this purpose.

As soon as the terms and conditions for legitimate handling or transfer of data are terminated, Labtech Ltd. shall immediately arrange for the deletion of personal data from the database and will notify you of the fact of the cancellation.

9. DATA SECURITY

In the course of data processing, Labtech Ltd. has become aware of the data stored in the electronic information system and stored on the traditional paper media with utmost care, strict confidentiality and with all legitimate means of protecting them, in particular by unauthorized access, alteration, transmission, disclosure, other abuses, deletions or destruction, as well as accidental destruction and damage by technical and organizational measures.

The IT system of Labtech Kft provides adequate security to manage data in an electronic information system. Our data controllers and partners, like Labtech Ltd, are responsible for protecting the data and are strictly used only for purpose. The data processed are accessible to authorized persons, data is credible and authenticated, data is unchanged and data is protected against unauthorized access.

Labtech Ltd. protects the data, in particular, against unauthorized access, alteration, transmission, disclosure, deletion or destruction, and incidental destruction and damage. Labtech Ltd. provides data security with technical, organizational and organizational measures that provide a level of protection that meets the risks associated with data management. We have adopted generally accepted technology and operational security solutions to prevent the loss, modification, destruction, or abuse of identifiable personal data. To the greatest extent possible, we ensure that the confidentiality of the personal data handled by Labtech Ltd. is ensured through appropriate confidentiality commitments and technical and safety measures. We only have access to personal data with our legitimate employees with confidentiality obligations and authorized data controllers.

Subscribing is voluntary and can be revoked at any time by using the link in the newsletter or by answering an email.

12. THE RIGHTS OF ACCESS TO THE DATA MANAGEMENT

12.1. Request for information

Persons concerned may request information about the personal data handled by Labtech Ltd., their source, the purpose, legal basis, duration of the data processing, the name, address and data management of the data processor, and, in the case of transmission of personal data, its addressee.

The request for information is only personally fulfilled by Labtech Ltd. For this purpose, the request for information may be sent to Labtech Ltd. in the form of a private document with full probative force, by email or by fax, by sending the appropriate identification information in writing. Labtech Ltd. will provide the information in writing to the address given by you in the shortest possible time, but not later than 30 days.

Please note that information on a particular datum per year is free of charge, for further information Labtech Ltd. may charge reimbursement.

12.2. Rectification

If the person concerned informs Labtech Ltd. that the personal data processed does not correspond to the reality or that Labtech Ltd. is aware otherwise of the personal data and the correct data, then the personal data is corrected by Labtech Ltd. Labtech Ltd. notifies the person concerned of the retification or refusal of his claim for correction or rectification.

12.3. Erasure or blocking

Affected parties are entitled to request the deletion or blocking of their personal data. Personal data will be blocked if it is based on the information available that the deletion would be prejudicial to the legitimate interests of the person concerned. The locked personal data will only be treated until the purpose of the data protection is excluded that excludes the deletion of personal data. We will notify you of the cancellation or blocking, or we will notify you of the rejection of your request for deletion or blocking.

12.4. Protest

Affected - except in cases of compulsory treatment - are entitled to object to the processing of personal data

- if the processing or transmission of their personal data is necessary solely for the fulfillment of the legal obligation of Labtech Ltd. or for the validation of the legitimate interests of Labtech Ltd. or a third party; or
- if the use or transfer of their personal data is done for direct business acquisition, opinion polling or scientific research, if they have not contributed to it; or
- in other cases specified by law.

Labtech Ltd. Shall review the protest within the shortest possible time, but within a maximum of 15 days of the submission of the request, to make a decision on its validity and inform the applicant in writing of its decision.

If the protest is well-grounded, Labtech Ltd. discontinues the processing of data, including further data collection and data transmission, locks the data and notifies the protest and the measures taken on the basis of those who have previously communicated the personal data affected by the protest and who are obliged to take action to enforce the right to protest.

12.5. Refusal to cooperate on direct marketing

Those concerned have the right to deny direct business acquisition mails, so-called direct marketing letters, at any time without justification.

13. NOTIFICATION OF CHANGE OF DATA

You have the right to declare changes to the data managed by Labtech Ltd. within 15 days within your own disposition. You will be responsible for all the consequences of failing to do so.

14. RIGHT OF REMEDY

With regard to personal data protection and data handling issues, the persons concerned may appeal to the National Data Protection and Information Authority (1125 Budapest, Szilágyi Erzsébet fasor 22 / c., Postal address: 1530 Budapest, Pf.:5) and apply for legal remedy.

15. LIMITATION OF RIGHTS

In exceptional cases, rights under the above may be restricted by a statutory provision, in particular to protect the rights of the data subject or others.

Labtech Ltd. performs data service contrary to your data management statement only and solely for the purpose of obtaining legal entities authorized by law, in statutory cases.

16. OTHERS

Labtech Ltd. reserves the right to make unilateral modifications to this Privacy Policy at any time. You will be informed in writing about the change in your information in one of the contact details given in the contract.
